3 Release of the portrait rights / publishing

3.1 Transfer rights to the model

The model receives the finalized photos (approx. 20 units) as download. The rights to the raw material and the raw material itself will remain with the photographer.

The model can use these photos for any personal purposes and self-promotion, such as create a model portfolio or the use on any website, etc (e.g. catalogs of modeling agencies or other third parties) freely and for free. Excepted from this are the photos, which fall under paragraph 3.3 special agreement for pictures with revocation of the transfer of the rights to the photographer.

When using the photos by the model the name of the photographer and / or the address of his website can be given.

The sale of photos by the model is allowed. The revenue generated is allowed to be keep by the model.

3.2 Transfer rights to the photographer

The model transfers the photographer irrevocably and indefinitely all rights for any use (including use in composing pictures) and publication of the images. Excluded from this is the publication in pornographic or unscrupulous media.

When using the photos by the photographer the name of the models can be specified.

The transmission of the rights can be revoked for individual images within 14 calendar days, calculated from the transfer of the pictures. A publication will only take place after the expiry of the opposition period. Pictures sent by post are deemed to be delivered 3 working days after dispatch. All images for which the transfer of the rights is revoked are subject to paragraph 3.3 special agreement for pictures with revocation of the transfer of rights to the photographer.

3.3 Special agreement for pictures with revocation of the transfer of rights to the photographer

For pictures, in which the transfer of the rights to the photographer has been revoked, a restricted right of use for the model applies. The model may not display these images on the Internet, especially in so-called "social networks", e.g. Facebook, etc.. This would contradict the data protection granted by the photographer.

These photographs may only be published in these media after approval by the photographer. At the same time, the photographer is irrevocably and irrevocably granted all rights for any use and publication on these images. Excluded from this is the publication in pornographic or dubious media.

4. Payment:

The photo shoot is for free and done on TFP (time for print) basis.

5. Liability:

The model and the photographer work at their own risk and mutually renounce any liability for damages incurred to persons, animals and movable goods.

6. Any other agreements:

This contract is subject to German law. Verbal agreements are not taken.

7. Salvatoric clause

If sections or individual terms of this contract are not legal, no longer or not completely correspond to the remaining parts of this agreement shall remain unaffected in their content and validity.
